## About the Theme

Policies and the recognition of human rights and child rights are witnessing a sea change during the pandemic. It is illegal to invite individuals to adopt orphans since no child may be adopted without the assistance of CARA. This competition invites participants to draft policies keeping in mind the psychological factor that is involved in the process of adoption. The Supreme Court of India directed the Centre and the States to investigate cases of illegal adoption. However, there are still no restrictions in place in this area. Participants have to develop a policy that offers a care system for such children while keeping their mental health and adoption legalities in mind. The idea is centric around the vulnerable children, specifically the abandoned or orphaned children and their well-being in aspects of law, psychology, and well-being.

- 1. Children in need of care and protection from Law
- 2. Transition period, change of environment, foster home to adoptive homes
- 3. International adoption, legalities
- 4. Same sex couples, queer couples wanting to adopt
- 5. Adoption of specially abled children and special needs (diseases)
- 6. Judicial separation- foster homes and mental health
- 7. 'Unwanted Children'-Children born out of rape, fatherless, unwanted teenage pregnancies, counselling

- 1. Mode of the Competition: Virtual
- 2. Eligibility
  - Any bona fide undergraduate/ postgraduate student of recognized Colleges/ Institutions/ Universities or Research Scholars, within or outside the territory of India, from all disciplines mainly from the field of Law, Psychology or Humanities/ Management or any other filed are eligible to participate
- 3. The official language of the competition shall be English only
- Each team can consist of max 3 members (researchers and speaker) participants can bring a teammate or can participate individually
- 5. No extra participant shall be allowed to register or participate in the competition.
- Each team shall be allotted a Team Code (TC). Teams shall not disclose their identity, University/ Institute/ College to other registered teams.
- 7. Discrimination based on caste, race, gender, religion, or community will result in disqualification.
- 8. The registration of the team shall be done by the team leader/ any other team member as the team may specify and fill in all the required details of the team members
